# Two Million Dollars Raised for Refugees!

On World Refugee Day 2019 the Refugee Family Reunification Trust reached a milestone worth celebrating when total donations reached two million dollars. Kate O'Malley, Senior Policy Advisor at the United Nations High Commissioner for Refugees (UNHCR) in Canberra, gifted the Trust the symbolic 'two millionth dollar'.

In recognising the Trust's work, the Regional Representative of UNHCR, Louise Aubin, noted that family reunification is of fundamental importance to a refugee's ability to integrate into a new country.



"I congratulate the Refugee Family Reunification Trust on the important work it has achieved through its committed support to refugee family reunification. Restoring family unity is a fundamental aspect of bringing back normality to the lives of refugees.

It can ease the sense of loss felt by many who, in addition to family, have lost their country, networks and life as they knew it. Family reunification can fundamentally affect a refugee's ability to integrate in their new country and is often a crucial step in their settlement. The Global Compact on Refugees, affirmed by UN General Assembly in late 2018 underlines the need for countries to do more to facilitate solutions, including through family reunification. The important work of the Trust and the support of its partners and donors over 18 years is a great example of the collaboration and effort needed to ensure the global commitment of responsibility sharing for refugees can be realized."

The Trust is a pure charity – all donations go to refugees. We rely entirely on volunteers; we receive no government funding; and our few, unavoidable, administration costs are paid from separate grants.

### Sisters of St Joseph

With extraordinary generosity, the Sisters of Saint Joseph, a Catholic religious women's order, provided a refugee family with a fully furnished, four bedroom home at a subsidised rental. Providing the house was just the beginning - they also supported the family in so many other very generous and thoughtful ways, including providing goods to ensure the family were welcome, stocking the pantry, covering the first six weeks' rent, paying the power bill for a period, paying for one of the children to attend summer camp, and so many other acts of practical kindness.

When the house was sold, the Sisters wished to continue to support our work, and donated \$100,000 to be used to support the initial rental costs for housing refugee families. This donation enables the Trust to help refugee families overcome the accommodation hurdle imposed by Immigration New Zealand (INZ) as part of the immigration process. Housing affordability and availability are major issues facing refugees who have family members joining them here, and this funding will assist a number of refugee families in a very direct and practical way.

Our heartfelt thanks to the Sisters of Saint Joseph for their tangible example of charity and compassion in action in our community.

#### Ōtari Parish Film Fundraiser

The Refugee Family Reunification Trust financially assists refugees, primarily in the Wellington region, to bring immediate family members to join them here. Reuniting these families greatly improves the lives of those refugees already living in New Zealand, and is critical to their successful resettlement and integration.

All money raised is used exclusively to help refugees pay for the expenses directly related to bringing family members from refugee situations. This includes application fees charged by, and medical reports required by, INZ, and the cost of airfares to bring approved family members to New Zealand.

The Trust is a registered charity and donations of \$5 or more are tax deductible.
